■ Reduced Errors

Frequently, mathematical errors and omissions occur when contribution forms are manually filled out and mailed from Employers to the Fund Office. ISSi-Remit has been designed to accurately capture, manage and transfer remittance data electronically. To further ensure accuracy, the system automatically calculates monies owed based on current rates and CBAs. The system can highlight specific fields that require Employer attention, such as missing information.

■ How It Works

Enrolled Employers are assigned a unique password that must be used during their login to the ISSi-Remit System. ISSi-Remit validates the Employer's username and password before access to the system is permitted.

Once the Employer is logged into the ISSi-Remit System they can select the remittance reporting period and contract. Additional features can include the ability to add and/or terminate Participants at the time of data entry, as well as make changes to the worker's class.

Once the Employer submits the report, the system automatically transfers remittance data to the Fund Office's ISSi System. Employers have the option to print a confirmation voucher to mail with check payment or to retain for their records. All data transfers are encrypted, providing maximum security and privacy. The system's historical reporting feature allows Employers to view previously-submitted electronic reports on demand.
